- Be responsible in the use of natural resources and reduce our consumption of resources, including those related to energy, waste, water, paper, plastic and travel consumption

- Manage and dispose of all waste in a responsible sustainable manner and maximise the efficient use of materials and resources, prioritising circular economy principles of rethink, reduce, re-use, recover and recycle, whilst actively

promoting recycling both internally and amongst our clients and suppliers

- Provide training to staff to ensure they are environmentally aware and that neither they, the community nor the environment are exposed to harm as a result of NJC operations
- Source and promote sustainable equipment and products in line with our Sustainable Procurement policy to minimise our environmental impact and reduce risk to customers and employee's health and safety, whilst managing our supply chain to work with companies who are in line with our ESG commitments
- Positively influence suppliers to minimise the use of materials, energy or processes which may be harmful to the environment
- Communicate with customers on sustainable and environmentally friendly products and services to meet their ESG commitments and reduce their scope 3 emissions
- Use an accredited programme to offset our environmental impact generated by our activities and achieve net zero carbon by 2030
- Get involved in external initiatives relevant to ESG and UN SDG commitments
- Agree targets and devise meaningful measurements in relation to reducing our consumption of resources, monitor output against these set targets and continuously improve our environmental performance
- Report and regularly communicate our environmental performance to our employees, clients and externally as part of our CSR
